REIMBURSEMENT RATE INCREASE FOR CERTAIN EVALUATION AND MANAGEMENT SERVICES

Effective for dates of service on and after January 1, 2020, ForwardHealth will increase reimbursement rates for some evaluation and management services performed by certain providers, as authorized by 2019 Wisconsin Act 9, the 2019-2021 biennial budget.

Reimbursement Rates

The following table lists which provider types can perform the identified evaluation and management service, the services that are eligible for the rate increase, and the rate increase percentage.
